AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING MANATEE COUNTY ORDINANCE 92-51; REGULATING THE TURNING OF MOTOR VEHICLES ON 67TH STREET WEST, APPROXIMATELY 150 FEET NORTH OF ITS INTERSECTION WITH MANATEE AVENUE WEST; ALL BEING COUNTY MAINTAINED ROADWAYS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; REQUIRING THE ERECTION OF APPROPRIATE SIGNS; PROVIDING FOR VIOLATIONS AND PENALTIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Manatee County, as a political subdivision of the State of Florida, is empowered, pursuant to Section 316.006(3), Florida Statutes, the Board of County Commissioners of Manatee County, Florida retains jurisdiction over the public streets, highways, roadways and parking areas located within the unincorporated areas of said County; and

WHEREAS, pursuant to Chapter 316.008(1)(l) of the Florida Statutes, the Board of County Commissioners may regulate or prohibit the turning of vehicles or specified types of vehicles.

NOW, THEREFORE, be it Ordained by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 92-51, Section 2, be amended to prohibit all vehicles from making U-turns at the following location;

**67th Street West, approximately 150 feet north of its intersection with Manatee Avenue West**

Section 2. This Ordinance shall take effect immediately upon receipt of official acknowledgment from the office of the Secretary of State of the State of Florida that the Ordinance has been filed with said office.

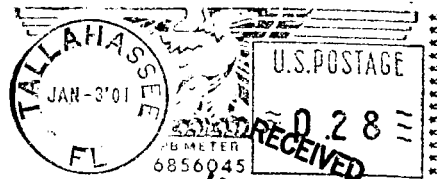
