

AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING ORDINANCE 84-06; TO REGULATE THE TRAVEL OF CERTAIN THROUGH TRAFFIC ON STREETS LOCATED IN BRADEN WOODS SUBDIVISION AND WEST GLENN SUBDIVISION; ALL BEING COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; REQUIRING THE ERECTION OF APPROPRIATE SIGNS; PROVIDING FOR VIOLATIONS AND PENALTIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Manatee County, as a political subdivision of the State of Florida is empowered, pursuant to Section 316.008(1)(n), Florida Statutes, to regulate or prohibit the use of heavily traveled streets by any class or kind of traffic found to be incompatible with the normal and safe movement of traffic; and

WHEREAS, the Transportation Department has reviewed the request from area residents and found the movement of through trucks to be incompatible with the safe movement of normal vehicular and pedestrian traffic in a residential area.

NOW, THEREFORE, be it Ordained by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-06, Section 1, be amended to add the following through truck zones:

BRADEN WOODS SUBDIVISION:

99th Street East - from Forrester Dr. to Braden Run
Oak Hammock Drive - from Linger Lodge Rd. to Forrester Dr.

WEST GLENN SUBDIVISION:

36th Street West - from 52nd Drive West to 53rd Avenue West
42nd Street West - from 52nd Drive West to 53rd Avenue West

Section 2. This Ordinance shall take effect immediately upon receipt of official acknowledgment from the office of the Secretary of State of the State of Florida that the Ordinance has been filed with said office.
