AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING ORDINANCE 92-51; REGULATING THE TURNING OF MOTOR VEHICLES AT THE INTERSECTIONS OF FACTORY SHOPS BOULEVARD AND 60TH AVENUE EAST (ELLENTON) AND AT THE NORTH ACCESS DRIVE TO NORTH RIVER VILLAGE AND 60TH AVENUE EAST (ELLENTON); ALL BEING COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 316.006(3) of the Florida Statutes, the Board of County Commissioners of Manatee County, Florida retains jurisdiction over the public streets, highways, roadways and parking areas located within the unincorporated areas of said County, and

WHEREAS, pursuant to Chapter 316.008(1)(l) of the Florida Statutes, the Board of County Commissioners may regulate or prohibit the turning of vehicles or specified types of vehicles.

NOW, THEREFORE, be it Ordained, by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 92-51, Section 2, be amended to add the following intersections to the listing of locations at which all vehicles are hereby prohibited from making a right turn on the red traffic signal indication, as specified below:

From eastbound Factory Shops Boulevard,  
onto southbound 60th Avenue East (Ellenton).

From westbound North Access Drive to North River Village,

Section 2. This Ordinance shall take effect immediately upon receipt of official acknowledgment from the office of the Secretary of State of the State of Florida that the Ordinance has been filed with said office.
