AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING ORDINANCE 98-11; REGULATING THE STOPPING, STANDING OR PARKING OF MOTOR VEHICLES ON 7TH AVENUE WEST, 9TH AVENUE WEST, 9TH STREET EAST/PENNSYLVANIA AVENUE, 11TH AVENUE WEST, 15TH AVENUE WEST, 27TH AVENUE WEST, 30TH AVENUE WEST, 34TH STREET WEST, 35TH STREET WEST, 36TH STREET WEST, 37TH STREET WEST, 37TH STREET COURT WEST, 38TH STREET WEST, 69TH STREET EAST/ERIE ROAD, 71ST AVENUE DRIVE EAST, 71ST STREET WEST, 84TH STREET COURT EAST, 85TH STREET COURT EAST AND GLENBROOKE LANE; ALL BEING COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Manatee County, as a political subdivision of the State of Florida, is empowered, pursuant to Section 316.008, Florida Statutes, to regulate the stopping, standing or parking of motor vehicles upon streets and highways within the County's jurisdiction;

NOW, THEREFORE, be it Ordained by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 99-06 is hereby rescinded in its entirety.

Section 2. Ordinance 98-11, Section 1.A, be amended to add the following rights-of-way:

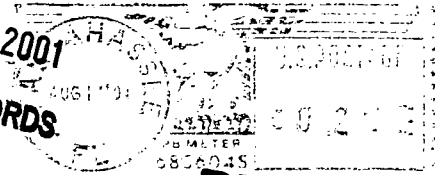
