

ORDINANCE 01-53

AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING ORDINANCE 98-11; REGULATING THE STOPPING, STANDING OR PARKING OF MOTOR VEHICLES ON 7TH STREET EAST, 18TH STREET EAST (ELLENTON), 29TH AVENUE EAST, 29TH STREET EAST (ELLENTON), 32ND AVENUE EAST, 36TH AVENUE EAST, 38TH AVENUE EAST, 45TH STREET EAST/LOCKWOOD RIDGE ROAD, 62ND AVENUE EAST, MANATEE AVENUE (ELLENTON), RIVER CLUB BOULEVARD, WIMMERLING AVENUE AND ON STREETS LOCATED IN HEATHER GLEN SUBDIVISION (PHASES I AND II) ; ALL BEING COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; REQUIRING THE ERECTION OF APPROPRIATE SIGNS; PROVIDING FOR VIOLATIONS AND PENALTIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Manatee County, as a political subdivision of the State of Florida, is empowered, pursuant to Section 316.008, Florida Statutes, to regulate the stopping, standing or parking of motor vehicles upon streets and highways within the County's jurisdiction.

NOW, THEREFORE, be it Ordained by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 98-11, Section 1.A, be amended to add the following rights-of-way:

- 32nd Avenue East** *From 9th St. E., west 300 feet.*
- 38th Avenue East** *From 19th St. Ct. E., east 300 feet.*  
*(south side only)*
- 45th Street East/** *From SR 70 to University Pkwy.*  
**Lockwood Ridge Road**
- 62nd Avenue East** *From 28th St. E., east 300 feet.*  
*(north side only)*
- Manatee Avenue** *From US Hwy. 301 N., south 175 feet.*  
*(west side only) (Ellenton)*
- River Club Boulevard** *From SR 70 to Braden Run Dr.*  
*(west side only)*
- Wimmerling Avenue** *From the east to the west property*  
*(south side only) line of 944 Wimmerling Ave.*
