AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING ORDINANCE 84-05; TO PROHIBIT THE TRAVEL OF VEHICLES AT SPEEDS IN EXCESS OF THE ESTABLISHED LIMIT ON 38TH AVENUE EAST, 71ST AVENUE DRIVE EAST, 84TH STREET COURT EAST, 85TH STREET COURT EAST AND ON STREETS LOCATED IN HEATHER GLEN SUBDIVISION (PHASES I AND II) AND IN STONE CREEK SUBDIVISION (FIRST AND SECOND ADDITIONS); ALL BEING COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; REQUIRING THE ERECTION OF APPROPRIATE SIGNS; PROVIDING FOR VIOLATIONS AND PENALTIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 316.189(2), Florida Statutes, the Board of County Commissioners of Manatee County, Florida, may set maximum and minimum speed limit in zones after an investigation and determination that such limits are reasonable and in conformity with criteria promulgated by the Florida Department of Transportation.

NOW, THEREFORE, be it Ordained by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-05, Section 1, be amended to add the following speed limit zones:

- 38th Avenue East - 30 MPH**
from 15th St. E. to US 301.
- 71st Avenue Drive East - 25 MPH**
from 84th St. Ct. E. to 85th St. Ct. E.
- 84th Street Court East - 25 MPH**
from Linger Lodge Rd. to 71st Ave. Dr. E.
- 85th Street Court East - 25 MPH**
from Linger Lodge Rd. to 71st Ave. Dr. E.

HEATHER GLEN SUBDIVISION (PHASES I & II)

- 60th Street Circle East - 25 MPH**
from 68th Dr. E. to 68th Dr. E.
- 61st Street East - 25 MPH**
from 64th Dr. E. to 68th Dr. E.
- 63rd Street East - 25 MPH**
from 64th Dr. E. to 68th Dr. E.
- 64th Drive East - 25 MPH**
from 61st St. E. to 67th St. E.
- 64th Lane East - 25 MPH**

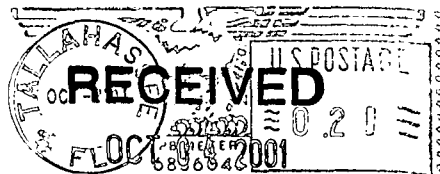
