**AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING
ORDINANCE 84-05; TO PROHIBIT THE TRAVEL OF VEHICLES AT SPEEDS
IN EXCESS OF THE ESTABLISHED LIMIT ON FT. HAMER ROAD (PARRISH)
AND LORRAINE ROAD; BEING A COUNTY MAINTAINED STREET LOCATED
WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA;
REQUIRING THE ERECTION OF APPROPRIATE SIGNS; PROVIDING FOR
VIOLATIONS AND PENALTIES; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, pursuant to Section 316.189(2), Florida Statutes, the Board of County Commissioners of Manatee County, Florida, may set maximum and minimum speed limit in zones after an investigation and determination that such limits are reasonable and in conformity with criteria promulgated by the Florida Department of Transportation.

NOW, THEREFORE, be it Ordained by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-05, Section 1, be amended to add the following speed limit zones:

- Ft. Hamer Road (Parrish)** **45 MPH**
from US Highway 301 to the Manatee River (Ft. Hamer).
- Lorraine Road** **50 MPH**
from State Road 64 to State Road 70.
