**AN ORDINANCE OF MANATEE COUNTY, FLORIDA  
PERTAINING TO TRAFFIC AND MOTOR VEHICLES;  
PROVIDING ADDITIONAL PENALTY FOR CIVIL  
TRAFFIC VIOLATIONS TO FUND DRIVERS EDUCATION  
PROGRAMS; PROVIDING FOR DISTRIBUTION;  
PROVIDING FOR SEVERABILITY; PROVIDING FOR  
THE REPEAL OF ORDINANCE 03-24; AND PROVIDING  
AN EFFECTIVE DATE.**

**WHEREAS**, Section 98 of Chapter 2002-20, Laws of Florida (§318.1215, Florida Statutes), known as the “Dori Slosberg Driver Education Safety Act” authorized this Board to enact an ordinance requiring the Clerk of the Court to collect an additional \$3.00 with each civil traffic penalty to be used to fund traffic education programs in public and non-public schools; and

**WHEREAS**, Ordinance 03-24 was passed and duly adopted by the Board of County Commissioners of Manatee County, Florida, on January 7, 2003. Such ordinance was codified at 2-22-2.2 in the Manatee County Code; and

**WHEREAS**, it is this Board’s intent that moneys collected be used to enhance driver education programs and not to replace other funding sources; and

**WHEREAS**, Section 318.1215, Florida Statutes, was amended in 2006 to authorize the Board of County Commissioners to enact an ordinance raising the \$3.00 fine to \$5.00; and

**WHEREAS**, it is the intent of this Board to permit the Clerk to collect future increases that may be authorized by an amendment to Section 318.1215, Florida Statutes; and

**WHEREAS**, it is respectfully requested that the courts of the 12<sup>th</sup> Judicial Circuit not waive the civil penalty provided by this ordinance.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of County Commissioners of Manatee County, Florida, that:

SECTION 1. Amendment of Code of Laws The Manatee County Code of Laws is hereby amended to substitute new **Section 2-22-2.2** as follows:

**Sec. 2-22-2.2 Drivers education program fund.**

(a) *Collection of fee.* Pursuant to Section 318.1215, Florida Statutes, as amended, the clerk of the court is hereby directed to collect an additional five dollars (\$5.00) with each civil traffic penalty, except for parking violations.

(b) *Fund created.* Funds collected by the clerk pursuant to this section shall be maintained in a separate county account, which may be known as the Driver Education Safety Trust Fund, to be used to financially assist driver education programs in the public and nonpublic schools within Manatee County. Such funds shall not be used to replace other funding sources. Such funds shall be used for direct educational expenses and shall not be used for administration.

(c) *Grants from fund.* In order to receive grants from the Driver Education Safety Trust Fund, programs shall be selected as program recipients on the basis of selection procedures which shall be developed by the county administrator and approved by resolution of the board of county commissioners. Final grant approvals shall be made by the board of county commissioners on an annual basis upon recommendation by the county administrator.

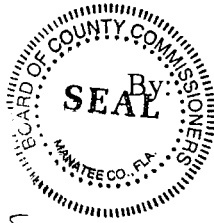
SECTION 2. If any section, subsection, sentence, clause or provision of this ordinance is held invalid, the remainder of this ordinance shall not be affected by such invalidity.

SECTION 3. Ordinance 03-24 is hereby repealed and this ordinance is substituted for it.

SECTION 4. This ordinance shall take effect immediately upon filing with the Department of State.
