PROVIDING FOR CODIFICATION; PROVIDING FOR AN

WHEREAS, Ordinance No. 08-12 was adopted by the Board of County Commissioners on March 25, 2008 and incorporates new provisions for the enforcement of the Noise Ordinance; and

WHEREAS, the Ordinance contains a provision in Sec. 2-21-34, subsection (1), subsection (c) which states "*Persons Affected*. Persons affected may include residents, passersby, law enforcement or code enforcement officials"; and

WHEREAS, Manatee County Sheriff Brad Steube has requested that the subparagraph relating to law enforcement officials be deleted from Ordinance No. 08-12; and

WHEREAS, it is the intent of the Board of County Commissioners that the ordinance should be enforced by the Manatee County Sheriff; and

WHEREAS, it is not the intent of the Board of County Commissioners to interfere with the proper enforcement of the ordinance by the Sheriff of Manatee County.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:

Section 1. Amendment to Code of Laws. The Manatee County Code of Laws is hereby amended to delete "law enforcement" from Section 2-21-34 so that it reads:

"(1) (c) *Persons affected*. Persons affected may include residents, passersby, or code enforcement officials."

Section 2. In all other respects, Ordinance 08-12 shall remain as originally adopted.

Section 3. Codification. The publisher of the County's Code of Laws, the Municipal Code Corporation, is directed to delete the above referenced section from the Code of Ordinances where indicated.

Section 4. Effective Date. This Ordinance shall take effect immediately upon filing with the Department of State.
