

ORDINANCE 20-18

AN ORDINANCE OF MANATEE COUNTY, FLORIDA, RELATING TO MOTOR VEHICLES AND TRAFFIC; AMENDING SUBSECTION 2-22-7(a) OF THE MANATEE COUNTY CODE; ADDING 31ST STREET COURT EAST FROM STATE ROAD 70 TO 52ND AVENUE EAST, 32ND STREET EAST FROM STATE ROAD 70 TO 52ND AVENUE EAST AND 52ND AVENUE EAST FROM 31ST STREET COURT EAST TO 32ND STREET EAST TO THE NO COMMERCIAL VEHICLE THROUGH ZONES ON ENUMERATED STREETS IN THE UNINCORPORATED AREAS OF MANATEE COUNTY, FLORIDA; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 316.008(1)(n), Florida Statutes (F.S.), authorizes the Board of County Commissioners of Manatee County to regulate or prohibit the use of heavily traveled streets by any class or kind of traffic found to be incompatible with the normal and safe movement of traffic; and

WHEREAS, the Public Works Department, in conjunction with the Manatee County Sheriff's Office, has reviewed requests from area residents and found that the use of commercial vehicles on the enumerated Manatee County roadways herein to be incompatible with the normal and safe movement of traffic on the enumerated roadways herein; and

WHEREAS, consideration has been given to roadway conditions, roadway functional classification, adjacent land use, alternate routes, and commercial vehicle volumes, and the Board of County Commissioners of Manatee County has determined that specified commercial vehicle through traffic on the enumerated streets herein should be prohibited; and

WHEREAS, the Board of County Commissioners of Manatee County finds that the provisions of this Ordinance are in the best interests of the County, its citizens, taxpayers, and business community.

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Manatee County:

Section 1. Section 2-22-7(a) of the Manatee County Code is hereby amended as follows:

Section 2-22-7(a). – Commercial vehicle through traffic restrictions.

- (a) *Commercial vehicle weight limit set; streets designated.* It shall be unlawful to operate any commercial vehicle as defined in Section 316.003(13), F.S., through a designated and posted county-maintained road in the

unincorporated areas of the county set forth in the attached list. Excluded from the restricted vehicles are authorized emergency vehicles as defined in Section 316.003(1), F.S., vehicles owned, operated or contracted for by a governmental entity or commercial vehicles being driven to a destination on a restricted road or only accessible through a restricted road.

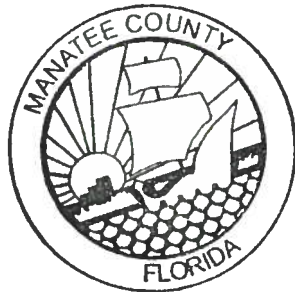

Section 2. Pursuant to Section 125.68(1), F.S., the Codifier shall codify the substantive amendments to the Manatee County Code contained in Section 1 of this Ordinance as provided therein, and shall not codify any other sections not designated for codification.

Section 3. If any section, subsection, sentence, clause, provision or word of this Ordinance is held invalid, same shall be severable and the remainder of this Ordinance shall not be affected by such invalidity, such that any remainder of the Ordinance shall withstand any severed provision, as the Board of County Commissioners would have adopted the Ordinance and its regulatory scheme even absent the invalid part.

Section 4. This Ordinance shall take effect immediately upon filing with the State of Florida Department of State.
