

ORDINANCE 20-20

AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING SECTION 2-22-8 OF THE MANATEE COUNTY CODE; INSTITUTING AND CREATING ADDITIONAL SPEED LIMIT ZONES TO INCLUDE 44TH AVENUE EAST FROM 15TH STREET EAST TO 45TH STREET EAST, CURTIS ROAD FROM STATE ROAD 70 TO END, MJ ROAD FROM STATE ROAD 70 TO 1.85 MILES SOUTH OF STATE ROAD 70, MJ ROAD FROM CLAY GULLY ROAD TO 4 MILES NORTH OF CLAY GULLY ROAD, PALM VIEW ROAD FROM BAYSHORE ROAD TO U.S. 41, PALM VIEW ROAD FROM 36TH AVENUE EAST TO END, TAYLOR ROAD FROM WAUCHULA ROAD TO END; AMENDING THE EXISTING SPEED LIMIT ZONE ON PALM VIEW ROAD FROM U.S. 41 TO 36TH AVENUE EAST; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 316.189(2), Florida Statutes (F.S.), authorizes the Board of County Commissioners of Manatee County to set maximum and minimum speed limits on county roads after an investigation determines that such limits are reasonable and in conformity with criteria promulgated by the Florida Department of Transportation; and

WHEREAS, the Public Works Department, in conjunction with the Manatee County Sheriff's Office, has conducted an investigation based on requests from area residents and determined that the changes to speed zones on the county roads identified herein are reasonable and in conformity with the criteria promulgated by the Florida Department of Transportation; and

WHEREAS, the Board of County Commissioners of Manatee County finds that the provisions of this Ordinance are in the best interests of the County, its citizens, taxpayers, and business community.

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Manatee County:

Section 1. Section 2-22-8(a)(1) of the Manatee County Code is hereby amended to include the following new and revised speed zones and limits:

<u>Curtis Road</u>	<u>S.R. 70 to the end</u>	<u>30</u>
<u>MJ Road</u>	<u>S.R. 70 to 1.85 miles south of S.R. 70</u>	<u>40</u>

Street	Extent	Speed (mph)
<u>MJ Road</u>	<u>Clay Gully Road to 4 miles north of Clay Gully Road</u>	<u>50</u>
<u>Palm View Road</u>	<u>Bayshore Road to U.S. 41</u>	<u>30</u>
<u>Palm View Road</u>	<u>U.S. 41 to S.R. 683 36th Avenue East (Ellenton Gillette Road)</u>	<u>45 35</u>
<u>Palm View Road</u>	<u>36th Avenue East (Ellenton Gillette Road) to the end</u>	<u>25</u>
<u>Taylor Road</u>	<u>Wauchula Road to the end</u>	<u>30</u>

Section 2. Pursuant to Section 125.68(1), F.S., the Codifier shall codify the substantive amendments to the Manatee County Code contained in Section 1 of this Ordinance as provided therein, and shall not codify any other sections not designated for codification.

Section 3. If any section, subsection, sentence, clause, provision or word of this Ordinance is held invalid, same shall be severable and the remainder of this Ordinance shall not be affected by such invalidity, such that any remainder of the Ordinance shall withstand any severed provision, as the Board of County Commissioners would have adopted the Ordinance and its regulatory scheme even absent the invalid part.

Section 4. This Ordinance shall take effect immediately upon filing with the State of Florida Department of State.
