A RESOLUTION OF MANATEE COUNTY, FLORIDA, IMPLEMENTING A DEPARTMENTAL REORGANIZATION PLAN; PROVIDING DEFINITIONS; ENUMERATING THE OFFICES AND DEPARTMENTS OF THE BOARD OF COUNTY COMMISSIONERS; PROVIDING FOR THE APPOINTMENT OF OFFICE AND DEPARTMENT DIRECTORS; PROVIDING FOR THE APPOINTMENT OF DIVISION DIRECTORS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Manatee County Board of County Commissioners wishes to provide for a coordinated administration of county departments as authorized by Florida Statutes §125.70 et seq. and by Manatee County Ordinance No. 78-2; and

WHEREAS, the County Administrator has prepared a departmental reorganization plan to reduce his managerial span of control in order to promote efficiency, improve productivity, increase administrative responsiveness, and reduce duplication of functions; and

WHEREAS, the Manatee County Board of County Commissioners has determined that the adoption of this departmental reorganization plan will enhance the delivery of county services and otherwise promote the health, safety, welfare, and quality of life of the residents of Manatee County.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. The services, functions, operations and personnel of Manatee County Government concerning which the County Administrator has responsibility and authority by virtue of Part III of Chapter 125 (Sections 125.70 et seq.), Florida Statutes, Manatee County Ordinance 78-2, and resolutions adopted pursuant thereto, shall be divided among offices, departments, divisions, and other governmental units in accordance with the organizational structure described herein.

Section 2.

a. There are hereby created the following Offices of Manatee County Government:

- 2 (i) The Office of Information Services;
- 3 (ii) The Office of Affirmative Action/Equal
- 4 Employment Opportunity;
- 5 (iii) The Office of Personnel;
- 6 (iv) The Office of Management and Budget;
- 7 (v) The Office of Central Services.

8 b. The Director of each Office shall be appointed

9 by the County Administrator, subject to confirmation by

10 the Board of County Commissioners ("the Board"), and

11 shall serve in such capacity at the pleasure of the

12 County Administrator.

13 c. The operations, functions, structure and per-

14 sonnel of each Office, including its division into

15 subunits, shall be as determined by the County

16 Administrator or, as to his or her respective Office,

17 by any Office Director to whom the County Administrator

18 shall assign the responsibility and prerogative to

19 determine the same.

20 Section 3.

21 a. There are hereby created the following

22 Departments of Manatee County Government:

- 23 (i) Public Safety Department;
- 24 (ii) Public Transportation Department;
- 25 (iii) Public Utilities Department;
- 26 (iv) Planning and Development Department;
- 27 (v) Parks and Recreation Department;
- 28 (vi) Land and Natural Resources Department;
- 29 (vii) Community Services Department.

30 b. The Director of each Department shall be

31 appointed by the County Administrator, subject to con-

32 firmation by the Board, and shall serve in such capa-

33 city at the pleasure of the County Administrator.

3 Section 3. Continued:

4 c. Subunits of each Department shall be known as
5 Divisions. The Divisions within any Department shall
6 be those established by written policy of the County
7 Administrator. The operations, functions, structure
8 and personnel of any Division or Department shall be as
9 determined by the County Administrator or, as to his
10 or her respective Department, by any Department Director
11 to whom the County Administrator shall assign the
12 responsibility and prerogative to determine the same.

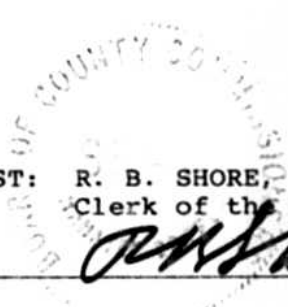

13 Section 4. This Resolution, and the reorganization of
