**RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS APPOINTING MARY E. SHEPPARD TO THE MANATEE COUNTY PLANNING COMMISSION; REAPPOINTING AND CONFIRMING TERMS OF OTHER MEMBERS OF THE MANATEE COUNTY PLANNING COMMISSION; PROVIDING FOR APPOINTMENTS UPON TERMINATION OF EXISTING TERMS; PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the Board of County Commissioners of Manatee County, Florida, on April 30, 1981, adopted Manatee County Ordinance 81-4, THE MANATEE COUNTY COMPREHENSIVE ZONING AND LAND DEVELOPMENT CODE; and

WHEREAS, the said MANATEE COUNTY COMPREHENSIVE ZONING AND LAND DEVELOPMENT CODE, Article 5, Section 501, established the Manatee County Planning Commission and authorized the Board of County Commissioners of said County to appoint the members thereof for four (4) year terms, in accordance with the terms of said Ordinance 81-4; and

WHEREAS, there is currently a vacancy on the Planning Commission due to the recent death of John Benson, Jr.; and

WHEREAS, the Board of County Commissioners wishes to fill that vacancy in accordance with the terms of said Ordinance 81-4; and

WHEREAS, the Board of County Commissioners appears to have appointed Planning Commissioners for terms with lengths not consistent with the provisions set forth in said Ordinance 81-4; and

WHEREAS, the Board of County Commissioners now desires and intends to correct any irregularities in the appointments of said Planning Commissioners, to confirm the appointments of individuals previously appointed and to establish the proper termination dates for such appointees.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, that:

1. Mary Sheppard, is hereby appointed to the Manatee County Planning commission to fill the vacancy on the Planning Commission caused by the recent death of John B. Benson, Jr. and that her term shall properly expire on May 12, 1988.
2. The appointment of the remaining members of the Planning Commission and correct termination dates for the terms of all members, is hereby verified and confirmed as set forth herein and that each member of the Planning Commission is hereby designated to fill a specific seat on the Planning Commission which seat numbers shall be used in the appointment of the future Board members, and to clarify the terms of such members:

Subsequent appointments of members to seats on the Planning Commission, upon the expiration of the terms of the present members, shall be for terms of four (4) years and in a manner consistent with Ordinance 81-4, as amended, which is also known as the Manatee County Comprehensive Zoning and Land Development Code.

4. This Resolution shall become effective immediately.


