RESOLUTION ESTABLISHING AUTHORIZED MANNING LEVEL CHANGES BY JOB CLASSIFICATION FOR THE OFFICE OF MANAGEMENT AND BUDGET, OFFICE OF FINANCIAL MANAGEMENT, PUBLIC SAFETY DEPARTMENT AND PUBLIC WORKS DEPARTMENT UNDER THE JURISDICTION OF THE BOARD OF COUNTY COMMISSIONERS.

WHEREAS, the Board of County Commissioners of Manatee County did, by Resolution dated 14 October 1976, establish manning levels by classification by Department for Departments under the direct jurisdiction of the Board.

WHEREAS, it has been determined that alterations to these manning levels are deemed necessary and appropriate for budgetary, classification and workload reasons,
