

A RESOLUTION MODIFYING THE SPECIAL ASSESSMENT ROLLS FOR
SEWER ASSESSMENT PROJECT NO. 301-5147
SAMOSET

WHEREAS, a sanitary sewer project was approved for construction under the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act"), and Resolution R-88-125, which confirmed the adoption of a special sewer assessment roll and established special assessment liens on real property designated as Samoset Project No. 301-5147; and

WHEREAS, said liens were recorded in Official Record Book 1231, Pages 668-1072, certified August 10, 1988 by Resolution R-88-187, Official Record Book 1231, Pages 663-664; and

WHEREAS, the preliminary assessment roll with reference to the above described project was properly filed with the Board of County Commissioners of Manatee County, Florida and said Board of County Commissioners did, pursuant to duly published notice, hold a public hearing on May 25, 1988 to consider the appropriateness of said sanitary sewer project and to consider objections to the confirmation of said preliminary roll.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, after giving careful consideration to all evidence presented concerning objections to the confirmation of the preliminary assessment roll, that said roll be and the same is hereby confirmed in all respects, with the following exceptions (each of which represent reductions in assessment amounts) presented as amendments to the certified roll:

1. Property of Harry Bakker: D.P. #48103.0005/5 from 7.5 ERU's at \$15,000.00 to 2.5 ERU's at \$5,000.00. Due to reduction in commercial meter size.
2. Property of Annie Mae Singletary: D.P. #47473.0000/4 from 2 ERU's at \$4,000.00 to 1 ERU at \$2,000.00.

COMBINE THE FOLLOWING D.P. NUMBERS

3. Combine D.P. #48098.0000/8 with D.P. #48099.0000/6. The property is owned by Luke Lengel. The sewer assessment was 2 ERU's at \$4,000.00, which should be reduced to 1 ERU at \$2,000.00.
4. Combine D.P. #48010.0000/3 with D.P. #48010.1005/1. The property is owned by Lawrence McCormick. The sewer assessment was 2 ERU's at \$4,000.00, which should be reduced to 1 ERU at \$2,000.00.
5. Combine D.P. #47178.0000/9 with D.P. #47177.0000/1. The property is owned by Harold Fortner. The sewer assessment was 2 ERU's at \$4,000.00, which should be reduced to 1 ERU at \$2,000.00.
6. Combine D.P. #16024.0000/2 with D.P. #16007.0000/7. The property is owned by the Samoset Community Club. The sewer assessment was 2 ERU's at \$4,000.00, which should be reduced to \$0.00. The Board made the motion to delete this assessment.

- 7. Combine D.P. #46440.0000/4 with D.P. #46441.0000/2. The property is owned by Edith West. The sewer assessment was 2 ERU's at \$4,000.00, which should be reduced to 1 ERU at \$2,000.00.

DELETE THE FOLLOWING D.P. NUMBERS

- 8. D.P. #15843.0000/6: Property of David Moore. The sewer assessment was 1 ERU at \$2,000.00, which should be reduced to \$0.00. Combined with 15845.0000/1. Already on sewer.
- 9. D.P. #15421.0000/1: Property of Mixon Fruit Farms, Inc. The sewer assessment was 1 ERU at \$2,000.00, which should be reduced to \$0.00. No service to be provided. Line cut back.
- 10. D.P. #55847.1015/5: Property of Phillip L. Burghardt. The sewer assessment was 3 ERU's at \$6,000.00, which should be reduced to \$0.00. Sewer line not to be constructed.
- 11. D.P. #15835.0000/2: Property of Ellen Lorene Williams. The sewer assessment was 1 ERU at \$2,000.00, which should be \$0.00. Paid fees and connected to existing sewer main on 34th Avenue East.
- 12. D.P. #46565.0000/1: Property of Theo E. Henderson. The sewer assessment was 1 ERU at \$2,000.00, which should be reduced to \$0.00. The lot was split to make required size for building lots. 1/2 to D.P. #46564.0000/1 and the other 1/2 to D.P. #46566.0000/6. Sewer assessment was 1 ERU at \$2,000.00 each.

BE IT FURTHER RESOLVED that the assessment roll, as modified herein, shall be delivered to the Tax Collector for further processing in accordance with the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act").
