A CORRECTIVE RESOLUTION TO CORRECT R-90-34
MODIFYING THE SPECIAL ASSESSMENT ROLL FOR ROAD ASSESSMENT PROJECT NO. 5080
PALMA SOLA HEIGHTS SUBDIVISION

WHEREAS, a Special Road Assessment Project was approved for construction under the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act"), and Resolution R-87-203, which confirmed the adoption of a special road assessment roll and established special assessment liens on real property designated as Palma Sola Heights Subdivision Project No. 5080; and

WHEREAS, said liens were recorded in Official Record Book 1205, Pages 714-730, certified November 24, 1987 by Resolution R-87-324, Official Record Book 1205, Pages 712-713; and

WHEREAS, the preliminary assessment roll with reference to the above described project was properly filed with the Board of County Commissioners of Manatee County, Florida and said Board of County Commissioners did, pursuant to duly published notice, hold a public hearing on November 24, 1987 to consider the appropriateness of said special road assessment project and to consider objections to the confirmation of said preliminary roll.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, after giving careful consideration to all evidence presented concerning objections to the confirmation of the preliminary assessment roll, that said roll be and the same is hereby confirmed in all respects, with the following exceptions (each of which represent reductions in assessment amounts) presented as amendments to the certified roll:

Assessed 45,000 square feet at \$.2314 = \$10,413.00
Revised Assessment = 16,049.91 square feet at \$.2314 = \$3,713.95
