A RESOLUTION MODIFYING THE SPECIAL ASSESSMENT ROLLS FOR  
SEWER ASSESSMENT PROJECT #301-2505

MARINELAND & VICINITY

WHEREAS, a sanitary sewer project was approved for construction under the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act"), and Resolution R-87-30, which confirmed the adoption of a corrected special sewer assessment roll and established special assessment liens on real property designated as Marineland & Vicinity Project #301-2505 Exhibit #1; and

WHEREAS, said liens were recorded in Official Record Book 1216, Pages 802-833 certified March 22, 1988 by Resolution R-88-68, Official Record Book 1216, Pages 798-800; and

WHEREAS, the preliminary assessment roll with reference to the above described project was properly filed with the Board of County Commissioners of Manatee County, Florida and said Board of County Commissioners did, pursuant to duly published notice, hold a public hearing on February 17, 1987, continued to March 12, 1987 and continued again to March 24, 1987, to consider the appropriateness of said sanitary sewer project and to consider objections to the confirmation of said preliminary roll.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, after giving careful considerations to all evidence presented concerning objections to the confirmation of the preliminary assessment roll, that said roll be and the same is hereby confirmed in all respects, with the following exceptions (each of which represent reductions in assessment amounts) presented as amendments to the certified roll:

Combine D.P. #18963.0000/9 with D.P. #18964.0000/7. The property is owned by Charles Edward Johnson. The sewer assessment was \$2,777.20 by front footage, which should be reduced to 1 ERU at \$2,000.00.

BE IT FURTHER RESOLVED that the assessment roll, as modified herein, shall be delivered to the Tax Collector for further processing in accordance with the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act").
