A RESOLUTION MODIFYING THE SPECIAL ASSESSMENT ROLLS FOR
SEWER ASSESSMENT PROJECT #301-2504

WHEREAS, a sanitary sewer project was approved for construction under the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act"), and Resolution R-87-37, which confirmed the adoption of a special sewer assessment roll and established special assessment liens on real property designated as Mockingbird/Palm Acres Project #301-2504, Exhibit #6; and

WHEREAS, said liens were recorded in Official Record Book 1216, Pages 839-843 certified March 22, 1988 by Resolution R-88-69, Official Record Book 1216, Pages 835-837; and

WHEREAS, the preliminary assessment roll with reference to the above described project was properly filed with the Board of County Commissioners of Manatee County, Florida and said Board of County Commissioners did, pursuant to duly published notice, hold a public hearing on March 10, 1987, to consider the appropriateness of said sanitary sewer project and to consider objections to the confirmation of said preliminary roll.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, after giving careful considerations to all evidence presented concerning objections to the confirmation of the preliminary assessment roll, that said roll be and the same is hereby confirmed in all respects with the following exceptions (each of which represent reductions in assessment amounts) presented as amendments to the certified roll:

Delete D.P. #53996.0000/5. The property is owned by James P. Ramos. The property was assessed by front footage under parent parcel #53997.0000/3 prior to the split.

BE IT FURTHER RESOLVED that the assessment roll, as modified herein, shall be delivered to the Tax Collector for further processing in accordance with the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act").
