WHEREAS, the State of Florida Department of Transportation proposes to construct or reconstruct a part of State Road N/A

AND WHEREAS, in order for the State of Florida Department of Transportation to further and complete said project, it is necessary that certain utilities and/or facilities within the Right-of-Way limits of said State Road \_\_\_\_\_ be adjusted, changed or relocated,

AND WHEREAS, the State of Florida Department of Transportation having requested the County of Manatee, Florida, to execute and deliver to the State of Florida Department of Transportation an Utilities Agreement, agreeing to make or cause to be made such adjustments, changes or relocations of said utilities and/or facilities as set out in said Agreement, and said request having been duly considered,

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Manatee, Florida, that the Chairman and Clerk of the Board of County Commissioners be and are hereby authorized to make, execute and deliver to the State of Florida Department of Transportation an Utilities Agreement for the adjustment, change or relocation of certain utilities within the Right-of-Way limits of said State Road N/A Section 13565-6612/6611;

BE IT FURTHER RESOLVED that this Resolution be forwarded to the State of Florida Department of Transportation at Tallahassee, Florida.
