

RESOLUTION R-90-141

A RESOLUTION OF MANATEE COUNTY, FLORIDA, AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY FOR THE TOWN OF LONGBOAT KEY'S EMERGENCY MEDICAL TRANSPORTATION SERVICES; PROVIDING THE WAIVER OF AN APPLICATION FEE OF FIVE HUNDRED DOLLARS (\$500.00) REQUIRED OF THE TOWN OF LONGBOAT KEY UNDER SECTION SIX (6) OF MANATEE COUNTY ORDINANCE 81-8; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Longboat Key has operated ambulance services since 1978; and

WHEREAS, the Town of Longboat lies partially within the boundaries of Manatee County, Florida; and

WHEREAS, the Board of County Commissioners of Manatee County enacted Ordinance 81-8 (now codified at Section 2-30 et seq Manatee Code of Laws) which prescribed rules and regulations for vehicles for hire, including ambulance services, which operated within Manatee County; and

WHEREAS, Section 4 of Ordinance 81-8 (now codified at Section 2-30 et seq Manatee Code of Laws) requires a Manatee County Certificate of Public Convenience and Necessity; and

WHEREAS, the Town of Longboat Key presently has a valid certificate from Manatee County in order to provide emergency medical services to residents of the Town of Longboat Key; and

WHEREAS, the Town of Longboat Key's certificate expires January 22, 1991; and

WHEREAS, Ordinance 81-8 (now codified at Section 2-30 et seq Manatee Code of Laws) is silent on renewals of certificates of public convenience and necessity; and

WHEREAS, prior Manatee County policy required a new application for a Certificate of Public Convenience and Necessity any time a certificate expired; and

WHEREAS, Section 6 of Ordinance 81-8 (now codified at Section 2-30 et seq Manatee Code of Laws) requires a fee of five hundred dollars (\$500.00) be submitted at the time the application for a Certificate of Public Convenience and Necessity is filed; and

WHEREAS, the Board of County Commissioners of Manatee County has previously waived the fee for the Town of Longboat Key's application for a Certificate of Public Convenience and Necessity; and

WHEREAS, the Town of Longboat Key has requested that Manatee County waive the application fee; and

WHEREAS, the Board of County Commissioners has conducted a public hearing to determine whether Manatee County should authorize the issuance of a Certificate of Public Convenience and Necessity for the Town of Longboat Key's request emergency medical transportation services; and

WHEREAS, the Board of County Commissioners of Manatee County has considered the Town of Longboat Key's request to have the application fee of five hundred dollars (\$500.00) waived for its application.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County that:

Section 1. Findings of Fact. In connection with the Town of Longboat Key's application for a Certificate of Public Convenience and Necessity for its emergency medical transportation services, the Board of County Commissioners of Manatee County makes the following findings of fact:

1. That a public hearing was conducted on October 30, 1990, in connection with the Town of Longboat Key's application for a Certificate of Public Convenience and Necessity for its emergency medical transportation services;
2. That proper notice of the public hearing was published twice as required by Manatee County Ordinance 81-8 (now codified at Section 2-30 et seq Manatee Code of Laws)
3. That the Town of Longboat Key's application contained all the information that was required to be supplied by Manatee County Ordinance 81-8 (now codified at Section 2-30 et seq Manatee Code of Laws)
4. That the information contained in the Town of Longboat Key's application demonstrates a need for the Town of Longboat Key to provide its own emergency medical transportation services;
5. That based on the evidence presented at the public hearing, there is a public convenience and necessity for the issuance of such a certificate to the Town of Longboat Key for its emergency medical transportation services;

6. That based on the evidence presented at the public hearing, the Board determines that it is proper to issue a Certificate of Public Convenience and Necessity to the Town of Longboat Key for its emergency medical transportation services;

Section 2. Authorization for Issuance of Certificate.

The Board of County Commissioners of Manatee County authorizes the issuance of a Certificate of Public Convenience and Necessity for the Town of Longboat Key's emergency medical transportation services.

Section 3. Waiver of Application Fee.

The Board of County Commissioners of Manatee County waives the fee of five hundred dollars (\$500.00) for the Town of Longboat Key's application for a Certificate of Public Convenience and Necessity for its emergency medical transportation services.

Section 4. Effective Date


This Resolution becomes effective on January 22, 1991.
