RESOLUTION RESCINDING GOLF COURSES FEES RESOLUTION 90-05, WHICH AMENDS THE 9-HOLE FEE FOR BOTH SUMMER AND WINTER SEASONS BY REDUCING THE 9-HOLE FEES

WHEREAS, the operation of the Manatee County Golf Course commenced on January 14, 1977, and the Buffalo Creek Golf Course opened December 15, 1988; and

WHEREAS, the Golf Course fees were first established by the Board of County Commissioners on October 5, 1976 and, by action of the Board, have been revised from time to time; and

WHEREAS, the Parks and Recreation Department Director has recommended, and the Parks and Recreation Board has agreed, that the fees for both Manatee County Golf Courses be increased in order to provide additional revenues to fund the debt service of a new 18-hole golf course in Ellenton; and

WHEREAS, the Board of County Commissioners has determined that a need exists to increase the fees for both Manatee County Golf Courses and that such increase is necessary, expedient and in the best interest of the citizens of Manatee County; and

WHEREAS, based upon recommendations and testimony provided by the Parks and Recreation Advisory Board and the Parks and Recreation Director, the Board of County Commissioners has determined that it is in the best economic interest of the Golf Courses and the citizens of Manatee County to provide certain discounts and privileges for residents of Manatee County as authorized herein; and

WHEREAS, in order to remain competitive with other golf courses, it is necessary to offer discounts and special promotions for golf fees; and that the Board of County Commissioners may approve, through resolution, any additional discounts and special promotions by majority vote on any regular Board Agenda, and such discounts and promotions will be in effect for the period of time specified in such resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS of Manatee County, Florida, as follows:

1. Manatee County Resident (hereinafter "Resident") as used in this resolution means one who has a true, fixed or permanent home in Manatee County and whenever absent, has the intention of returning to Manatee County. The genuineness of the intention to return to Manatee County must be manifested by an ongoing physical presence together with indicia that his presence is something other than merely transitory in nature. Two of the following must be provided as indicia of a resident:

- a. A sworn affidavit declaring that the affiant has established a permanent home in Manatee County and the address or location of the home.
- b. A permanent Florida drivers license with a Manatee County address.
- c. A Manatee County voters registration card.
- d. A Manatee County homestead exemption certificate.
- e. A Manatee County property tax receipt.

2. The rate schedule adopted by the Board of County Commissioners in open session on July 10, 1990, under Resolution R-90-05 shall be rescinded as of 12:01 am on the 21st day of August, 1990, immediately thereafter this resolution and the following rates shall be in effect:
