

**RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS RECONSTITUTING THE
MANATEE COUNTY CODE ENFORCEMENT
BOARD; PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the creation of a Code Enforcement Board is authorized by the enactment of Chapter 82-37, Laws of Florida, and Chapter 162, Florida Statutes; and

WHEREAS, the Board of County Commissioners of Manatee County Florida, adopted Ordinance 90-01, the Manatee County Land Development Code, on July 25, 1990, with an effective date of October 15, 1990; and

WHEREAS, the said Manatee County Land Development Code, Section 305, establishes the Manatee County Code Enforcement Board and authorizes the Board of County Commissioners of said County to appoint the members thereof, in accordance with the terms of said Ordinance 90-01; and

WHEREAS, it is the desire of the Board of County Commissioners to reconstitute the Manatee County Code Enforcement Board in its entirety at this time, as the provisions of the Land Development Code and the powers, duties, and responsibilities of the Code Enforcement Board have been significantly changed under the revised Land Development Code; and

WHEREAS, the initial terms of such Code Enforcement Board members shall be staggered to assure long-term continuity of the Code Enforcement Board and to meet the requirement that no more than two seats shall expire in a single year; appointment of members after the initial term shall be for three years; and

WHEREAS, the Code Enforcement Board, whenever possible, shall include an architect, a business person, an engineer, a general contractor, a subcontractor and a realtor;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, that:

1. Rev. David Green is hereby appointed to Seat #1 of the Manatee County Code Enforcement Board, and whose term shall expire on October 14, 1991.
2. Edward Cipriani, Jr. is hereby appointed to Seat #2 of the Manatee County Code Enforcement Board, and whose term shall expire on October 14, 1991.

- 3. E. Jane Long is hereby appointed to Seat #3 of the Manatee County Code Enforcement Board, and whose term shall expire on October 14, 1992.
- 4. Robert B. Whitehead is hereby appointed to Seat #4 of the Manatee County Code Enforcement Board, and whose term shall expire on October 14, 1992.
- 5. Robert L. French is hereby appointed to Seat #5 of the Manatee County Code Enforcement Board, and whose term shall expire on October 14, 1992.
- 6. Richard S. Kesten is hereby appointed to Seat #6 of the Manatee County Code Enforcement Board, and whose term shall expire on October 14, 1993.
- 7. Richard Fawley is hereby appointed to Seat #7 of the Manatee County Code Enforcement Board, and whose term shall expire on October 14, 1993.
- 8. The unexpired terms of all previously appointed Code Enforcement Board members shall be terminated upon this Resolution becoming effective.
- 9. This Resolution shall become effective October 15, 1990.
