

**RESOLUTION OF THE BOARD OF COUNTY  
COMMISSIONERS RECONSTITUTING THE  
MANATEE COUNTY BOARD OF ZONING  
APPEALS; PROVIDING AN EFFECTIVE  
DATE.**

**WHEREAS**, the Board of County Commissioners of Manatee County Florida, adopted Ordinance 90-01, the Manatee County Land Development Code, on July 25, 1990; with an effective date of October 15, 1990; and

**WHEREAS**, the said Manatee County Land Development Code, Section 303, establishes the Manatee County Board of Zoning Appeals and authorizes the Board of County Commissioners of said County to appoint the members thereof, in accordance with the terms of said Ordinance 90-01; and

**WHEREAS**, it is the desire of the Board of County Commissioners to reconstitute the Manatee County Board of Zoning Appeals in its entirety at this time, as the total number of Board of Zoning Appeals members is being increased by the revised Land Development Code from 5 to 7, and the powers, duties, and responsibilities of the Board of Zoning Appeals have been significantly changed under the revised Land Development Code; and

**WHEREAS**, the initial terms of such Board of Zoning Appeals members shall be staggered to assure long-term continuity of the Board of Zoning Appeals and to meet the requirement that no more than two seats shall expire in a single year; appointment of members after the initial term shall be for four years; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Manatee County, Florida, that:

1. J. Gregory Young is hereby appointed to Seat #1 of the Manatee County Board of Zoning Appeals, and this term shall expire on October 14, 1991.
2. Dana Sanborn is hereby appointed to Seat #2 of the Manatee County Board of Zoning Appeals, and this term shall expire on October 14, 1992.
3. Michael Bryant is hereby appointed to Seat #3 of the Manatee County Board of Zoning Appeals, and this term shall expire on October 14, 1992.
4. David Holt is hereby appointed to Seat #4 of the Manatee County Board of Zoning Appeals, and this term shall expire on October 14, 1993.

- 5. Charles Conoley is hereby appointed to Seat #5 of the Manatee County Board of Zoning Appeals, and this term shall expire on October 14, 1993.
- 6. Richard Breeze is hereby appointed to Seat #6 of the Manatee County Board of Zoning Appeals, and this term shall expire on October 14, 1994.
- 7. Elliott Grosh is hereby appointed to Seat #7 of the Manatee County Board of Zoning Appeals, and this term shall expire on October 14, 1994.
- 8. The unexpired terms of all previously appointed Board of Zoning Appeals members shall be terminated upon this Resolution becoming effective.
- 9. This Resolution shall become effective October 15, 1990.
