RESOLUTION NO. R-90-166

A RESOLUTION OF THE COUNTY COMMISSION OF MANATEE COUNTY, FLORIDA, SUPPORTING THE APPLICATION OF FLORIDA HOUSING AFFORDABILITY, INC. (A FLORIDA NON-PROFIT CORPORATION) TO THE FLORIDA DEPARTMENT OF COMMUNITY AFFAIRS CONSISTENT WITH LOCAL PLANS AND REGULATIONS FOR ELIGIBILITY AS A SPONSOR UNDER THE STATE'S COMMUNITY IMPROVEMENT ACT TAX CREDIT PROGRAM.

WHEREAS, the State of Florida has adopted the Community Improvement Act of 1980, as amended, establishing a tax credit program under Section 220.183 Florida Statutes (1982) to provide community contribution tax credits for private corporations; and

WHEREAS, Florida Housing Affordability, Inc. is a Florida Non-Profit Corporation organized to assist the development, management, maintenance, and provision of adequate affordable housing in the State of Florida for those persons or families in need of assistance in affording rental or ownership of such housing; and

WHEREAS, the Manatee County project included in the application for sponsorship in the State of Florida Community Contribution Tax Incentive Program is consistent with the Manatee County Comprehensive Plan and other regulations;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, THAT:

1. The Board of County Commissioners of Manatee County, Florida supports Florida Housing Affordability, Inc.'s application to the State of Florida for sponsorship under the Community Contribution Tax Incentive Program consistent with local plans and regulations for eligibility as a sponsor under the State's Community Contribution Tax Incentive Program.
2. The Board of County Commissioners endorses and supports the application and requests the State of Florida to confer such sponsorship on Florida Housing Affordability, Inc.
3. The Clerk of Circuit Court is hereby directed to furnish a certified copy of this Resolution to appropriate representatives of Florida Housing Affordability, Inc.
4. This Resolution shall take effect immediately upon its adoption.
