

**RESOLUTION CONFIRMING THE ESTABLISHMENT OF BRANCH OR AUXILIARY OFFICES
OF THE TAX COLLECTOR OF MANATEE COUNTY, FLORIDA**

WHEREAS, the City of Bradenton, Florida, is the Countyseat of the County of Manatee, Florida, and Article VIII, Section 1(k) of the Florida Constitution provides that branch offices for the conduct of County business may be established outside of the Countyseat within the County by resolution of the Board of County Commissioners in the manner prescribed by law, and Section 125.222 of the Florida Statutes provides that auxiliary county offices may be established in places outside of the Countyseat if there is adequate space and facilities at said places, and

WHEREAS, a Resolution was adopted July 26, 1977, by the Board of County Commissioners of Manatee County, Florida, authorizing the Tax Collector of Manatee County, Florida, to establish branch offices outside of the City of Bradenton, and certain branch or auxiliary offices have been established by the Tax Collector outside the City of Bradenton and within the County of Manatee, Florida and

WHEREAS, adequate space and facilities are available in each of the hereinafter identified branch or auxiliary offices of the Tax Collector of Manatee County, Florida, and it is expedient and to the best interests of the County of Manatee, Florida, the Tax Collector of Manatee County, Florida, and the taxpayers of said County to approve, ratify and confirm the establishment of the hereinafter identified branch or auxiliary offices of said Tax Collector.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida that:

1. The establishment of the permanent branch or auxiliary offices of the Tax Collector of Manatee County, Florida, at the hereinafter identified locations, is hereby approved, ratified and confirmed:

- a. **Lakeside Tax & Tag Office:** Lakeside Plaza - 2114 Cortez Road - P. O. Box C - Bradenton, Florida - 34207
- b. **Island Tag Office:** 5508 C UNIT - Marina Drive - Holmes Beach, Florida - 34218
- c. **Palmetto Tax & Tag Office:** 1331 U.S. 301 Blvd. - Palmetto, Florida - 34221
- d. **Resort Tax and Administrative:** 1023 Manatee Avenue - Bradenton, Florida - 34205

2. The establishment of the branch or auxiliary offices of the Tax Collector of Manatee County, Florida, at the hereinafter identified locations are as follows:
