A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA AUTHORIZING DISBURSEMENT OF COUNTY FUNDS TO THE MANATEE COUNTY PUBLIC HEALTH UNIT TO IMPLEMENT THE MATERNAL CARE/ACUTE CARE CLINIC AND AUTHORIZING THE CHAIRMAN TO EXECUTE A LETTER TO THE MANATEE COUNTY PUBLIC HEALTH UNIT

WHEREAS, the Manatee County Public Health Unit provides health services to the citizens of Manatee County; and

WHEREAS, the Creation of Minor Modifications in the Indigent Health Care System for Manatee County includes the provision of maternal care services and an acute care clinic at the Public Health Unit; and

WHEREAS, on November 7, 1990 the Manatee County Board of County Commissioners conceptually approved the establishment of The Creation of Minor Modifications in the Indigent Health Care System for Manatee County; and

WHEREAS, a formal agreement to provide for funding maternal care services and an acute care clinic in accordance with The Creation of Minor Modifications in the Indigent Health Care System for Manatee County is pending execution; and

WHEREAS, the Health Care Advisory Committee recommends to the Board of County Commissioners that funding be provided for initial implementation in the amount of \$125,000 for said purpose; and

WHEREAS, the Manatee County Public Health Unit requires disbursement of said funding to continue to provide maternal care and acute care services to the community.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, that

1. The Board of County Commissioners authorizes the Clerk of the Circuit Court, forthwith, to disburse funds to the Manatee County Public Health Unit in the amount of \$125,000 for deposit into the Manatee County Public Health Unit Trust Fund. Such payment represents Manatee County's funding to the Public Health Unit for the provision of maternal Health Care Services and an acute care clinic as conceptually approved by the Board of County Commissioners for the period March 1, 1990 through September 30, 1990.
2. The Board of County Commissioners hereby authorizes the Chairman to execute a letter to the Manatee County Public Health Unit as attached hereto.

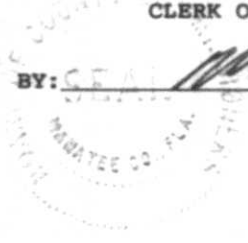
