**WHEREAS**, a sanitary sewer project was approved for construction under the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act"), and Resolution **R-88-194**, which confirmed the adoption of a special sewer assessment roll and established special assessment liens on real property designated as **Washington Park** Project No. **301-5152**; and

**WHEREAS**, said liens were recorded in Official Record Book **1251**, Pages **2562-2705**, certified **February 20, 1989** by Resolution **R-89-21**, Official Record Book **1251**, Pages **2541-2542**; and

**WHEREAS**, the preliminary assessment roll with reference to the above described project was properly filed with the Board of County Commissioners of Manatee County, Florida and said Board of County Commissioners did, pursuant to duly published notice, hold a public hearing on **September 27, 1988** to consider the appropriateness of said sanitary sewer project and to consider objections to the confirmation of said preliminary roll.

**NOW, THEREFORE BE IT RESOLVED** by the Board of County Commissioners of Manatee County, Florida, after giving careful consideration to all evidence presented concerning objections to the confirmation of the preliminary assessment roll, that said roll be and the same is hereby confirmed in all respects, with the following exceptions (each of which represent reductions in assessment amounts) presented as amendments to the certified roll.

**MOVE SEWER ASSESSMENT FROM D.P. #25034.0000/0 TO D.P. #25034.0005/9 - PROPERTY OF MATHERIA EADY - SEWER ASSESSMENT = \$ 2,000.00 (1 ERU)**

**BE IT FURTHER RESOLVED** that the assessment roll, as modified herein, shall be delivered to the Tax Collector for further processing in accordance with the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act").

**ADOPTED** with a quorum present and voting this the 15<sup>th</sup> day of February, 1994.
