

RESOLUTION R-94-75

**A RESOLUTION OF MANATEE COUNTY,
FLORIDA, ACCEPTING FOR THE PUBLIC
SELECTED RIGHTS OF WAY AND UTILITY
EASEMENTS APPEARING IN THE PLATS OF
MORTON VILLAGE, A CONDOMINIUM**

WHEREAS, on or about December 15, 1978 and February 25, 1980, the owners and developers of tracts of land lying within Section 16, Township 35 South, Range 17 East in Manatee County, Florida, recorded condominium plats encompassing said lands, with said plats labelled as Morton Village, a Condominium; and

WHEREAS, said plats were recorded in the Official Records of Manatee County, Florida, at Condominium Book 9, Page 1, et seq. and Condominium Book 10, Page 92, et seq.; and

WHEREAS, both of the aforementioned plats served to dedicate to Manatee County and to the public all rights of way, utility easements and ingress/egress easements as shown on the plats; and

WHEREAS, the Manatee County Board of County Commissioners, on behalf of Manatee County and the public, is desirous of formally accepting selected rights of way and easements as depicted on the aforementioned plats.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, as follows:

1. Manatee County hereby accepts, for the use of the public forever, that certain right-of-way, being 50 feet in width and labelled as Morton Boulevard, appearing at Condominium Book 9, Pages 1 and 2 and Condominium Book 10, Pages 92 and 93, of the Public Records of Manatee County, Florida.

2. Manatee County hereby accepts, for the use of the public forever, that certain right-of-way, being 9 feet in width and abutting the west side of 34th Street West, appearing at Condominium Book 9, Pages 1 and 2 and Condominium Book 10, Page 93, of the Public Records of Manatee County, Florida.

3. Manatee County hereby accepts, for the use of the public forever, that certain lift station easement, measuring 25 feet by 25 feet and abutting the north side of the aforementioned Morton

Boulevard, appearing at Condominium Book 9, Pages 1 and 2 and Condominium Book 10, Pages 92 and 93, of the Public Records of Manatee County, Florida.

4. Manatee County hereby expressly rejects the offer of dedication of all other rights of way and ingress/egress easements appearing at Condominium Book 9, Pages 1 and 2 and Condominium Book 10, Pages 92 and 93, of the Public Records of Manatee County, Florida.

5. The Clerk of the Circuit Court is hereby directed to promptly record this Resolution in the Official Records of Manatee County, Florida.

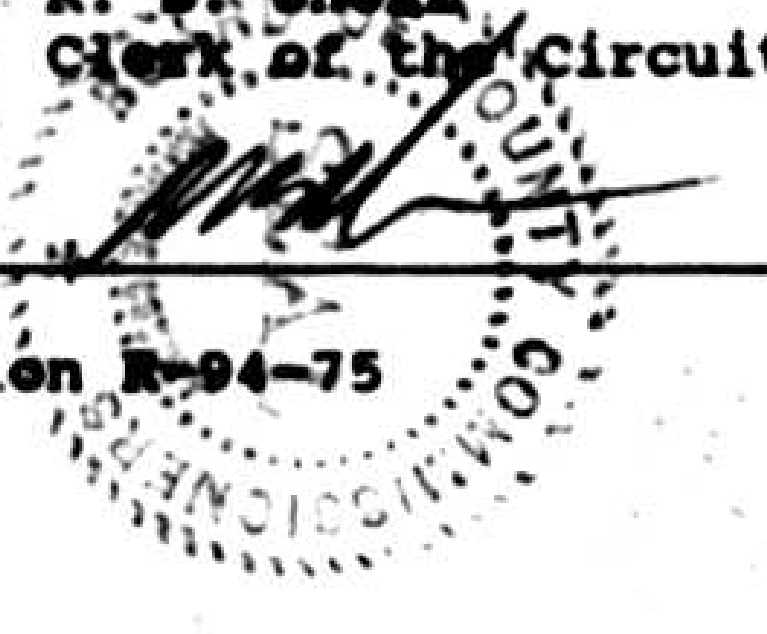
