A RESOLUTION MODIFYING THE SPECIAL ASSESSMENT ROLLS FOR
SEWER ASSESSMENT PROJECT NO. 5147
SANOSSET

WHEREAS, a sewer project was approved for construction under the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act"), and Resolution R-88-187, which confirmed the adoption of a special sewer assessment roll and established special assessment liens on real property designated as Sanosset Project No. 5147; and

WHEREAS, said liens were recorded in Official Record Book 1231, Pages 660-1073, certified August 10, 1988 by Resolution R-88-187, Official Record Book 1231, Pages 663-664; and

WHEREAS, the preliminary assessment roll with reference to the above described project was properly filed with the Board of County Commissioners of Manatee County, Florida and said Board of County Commissioners did, pursuant to duly published notice, hold a public hearing on May 25, 1988 to consider the appropriateness of said sewer project and to consider objections to the confirmation of said preliminary roll.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, after giving careful consideration to all evidence presented concerning objections to the confirmation of the preliminary assessment roll, that said roll be and the same is hereby confirmed in all respects, with the following exceptions (each of which represent reductions in assessment amounts) presented as amendments to the certified roll.

ADD THE FOLLOWING PARCEL:

46877.1000/6 - PROPERTY OF PATRICIA L. THORNTON
1207 39TH AVENUE WEST, BRADENTON, FLORIDA
ORIGINAL SEWER ASSESSMENT = \$ 2,000.00

NOTE: THIS PARCEL WAS PAID OFF IN ERROR. THE PAYOFF DATE WAS MAY 17, 1994 FOR \$ 1,399.62.

BE IT FURTHER RESOLVED that the assessment roll, as modified herein, shall be delivered to the Tax Collector for further processing in accordance with the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act").
