CONFIRMING INTERLOCAL AGREEMENT FOR
CHILD SUPPORT HEARING OFFICER AND
CONFIRMING AMOUNT BUDGETED FOR
HEARING OFFICER SERVICES.

WHEREAS, on December 20, 1988, Manatee County, Florida, did approve and execute an Interlocal Agreement with Sarasota County, Florida, for Child Support Hearing Officer expenses (hereinafter called the "Agreement"); and

WHEREAS, Paragraph 5 of the Agreement provides for the automatic renewal of the Agreement beyond Fiscal Year 1988-89 upon adoption of counterpart resolutions by the participating counties establishing the percentage of payment to be contributed by each county and the total amount budgeted for all salary and benefits for the Hearing Officer; and

WHEREAS, the participating counties have agreed upon the appropriate budget and percentage allocation to be paid by each county.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, as follows:

1. The Agreement is hereby ratified and confirmed.
2. The annual budget for the Child Support Hearing Officer, the percentage to be paid by Sarasota County and Manatee County, and the monthly payments to be made by Manatee County, shall be as provided in attached Exhibit "A".

3. The Clerk of the Circuit Court is requested to provide a certified copy of this Resolution to the Board of County Commissioners of Sarasota County.

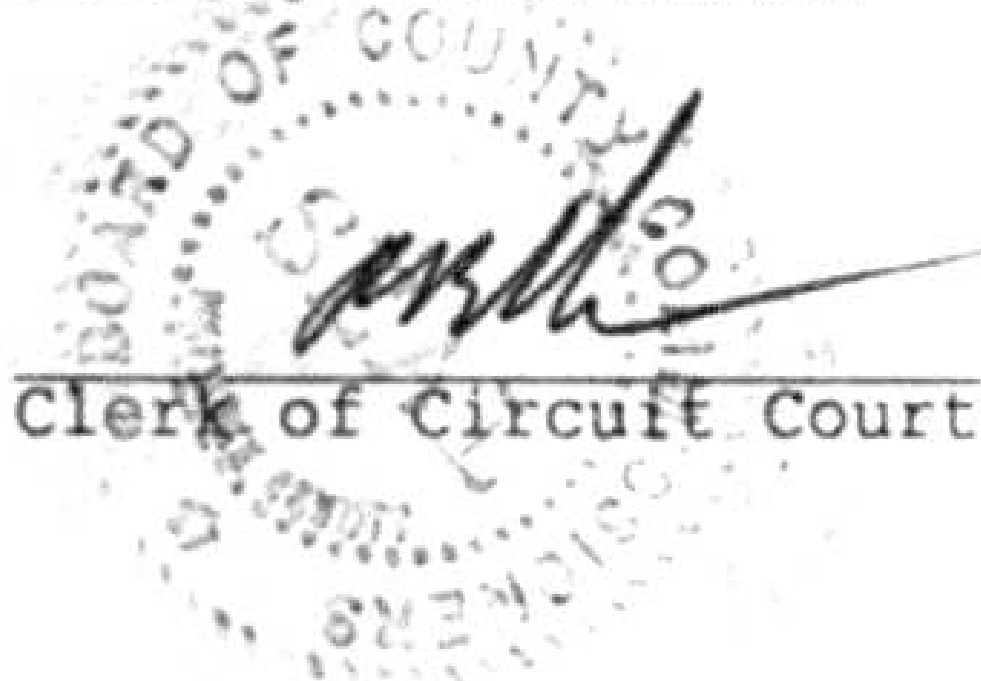
