WHEREAS, a sanitary sewer project was approved for construction under the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act"), and Resolution R-88-194, which confirmed the adoption of a special sewer assessment roll and established special assessment liens on real property designated as Washington Park Project No. 301-5152; and

WHEREAS, said liens were recorded in Official Record Book 1251, Pages 2562-2705, certified February 28, 1989 by Resolution R-89-21, Official Record Book 1251, Pages 2541-2542; and

WHEREAS, the preliminary assessment roll with reference to the above described project was properly filed with the Board of County Commissioners of Manatee County, Florida and said Board of County Commissioners did, pursuant to duly published notice, hold a public hearing on September 27, 1988 to consider the appropriateness of said sanitary sewer project and to consider objections to the confirmation of said preliminary roll.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, after giving careful consideration to all evidence presented concerning objections to the confirmation of the preliminary assessment roll, that said roll be and the same is hereby confirmed in all respects, with the following exceptions (each of which represent reductions in assessment amounts) presented as amendments to the certified roll.

**COMBINE THE FOLLOWING PARCELS:**

25134.0000/8 - PROPERTY OF ARBZINE BURNEY AND LILLIE EVANS  
25134.0005/7 SEWER ASSESSMENT = \$ 4,000.00 TOTAL

25134.0010/7 - SEWER ASSESSMENT = 1 ERU = \$ 2,000.00

BE IT FURTHER RESOLVED that the assessment roll, as modified herein, shall be delivered to the Tax Collector for further processing in accordance with the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act").
