A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS, OF MANATEE COUNTY, FLORIDA, ACCEPTING A GRANT FROM THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION, UNDER THE LAND AND WATER CONSERVATION FUND PROGRAM FOR THE DEVELOPMENT OF DUETTE PARK.

WHEREAS, The Florida Department of Environmental Protection provides funding through the U.S. Department of the Interior, National Park Service for local government entities to develop land for recreation purposes; and

WHEREAS, Duette Park is part of the Manatee County Capital Improvement Program and is slated for development as an outdoor recreation park; and

WHEREAS, Manatee County submitted a grant application under the Land and Water Conservation Fund Program for the development of Duette Park; and

WHEREAS, the Florida Department of Environmental Protection has notified Manatee County that the application for Duette Park has been recommended for funding.

NOW THEREFORE BE IT RESOLVED, by the Board of County Commissioners of Manatee County, Florida, that:

1. The acceptance of the grant from the Florida Department of Environmental Protection for the development of Duette Park is hereby authorized.
2. Staff is hereby authorized to furnish all documentation required for submission to the Florida Department of Environmental Protection.
3. The Chairman, or in his absence, the Vice Chairman are authorized to execute all appropriate documents with regards to the acceptance of this grant.


