

RESOLUTION 97-240

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AUTHORIZING THE EXPENDITURE OF TOURISM TRUST FUNDS FOR THE PURPOSE OF A SEASONAL RECOGNITION OF SERVICE FOR SENIOR AND OTHER VOLUNTEERS AT THE TOURIST INFORMATION CENTER.**

WHEREAS, the Board of County Commissioners of Manatee County, Florida, has previously adopted Ordinance 97-28 authorizing the expenditure of County funds to promote, make-known and engender good will toward the County; and

WHEREAS, Ordinance 97-28 provides that any programs established and expenditures authorized shall be approved by resolution of the board of County Commissioners; and

WHEREAS, the Board of County Commissioners has considered this Resolution and determined that the expenditure would accomplish the purposes authorized in Ordinance 97-28 and as set forth more fully herein

NOW THEREFORE, be it resolved by the Board of County Commissioners of Manatee County, Florida, as follows.

SECTION 1. PURPOSE

It shall be the purpose of this Resolution to recognize the service of thousands of hours by volunteers at the Tourist Information Center in Ellenton

SECTION 2. EXPENDITURES

This resolution will be applicable to the volunteers and staff of the Convention & Visitors Bureau, and is an allowable expense of Tourism Trust Funds under F.S. 125 0104

SECTION 3. APPROVAL OF EXPENDITURES

Expenditures of Tourism Trust Funds for the purpose listed above falls within previously approved budgetary allotments for the Tourist Information Center. The County Administrator is hereby granted the authority to develop and maintain procedures outlining aspects to be followed for authorization and approval of expenditures, and for use of space within the Manatee Convention & Civic Center for the event.

This Resolution may be rescinded by the Board of County Commissioners, however, rescinding this Resolution shall in no way prohibit any lawful expenditures made prior to the date this Resolution was rescinded or impair any contracts entered into prior to the date this Resolution was rescinded

This Resolution shall take effect immediately upon adoption.
