

**A RESOLUTION MODIFYING THE SPECIAL ASSESSMENT ROLLS FOR
ROAD ASSESSMENT PROJECT NO. 6018360 AND
SEWER ASSESSMENT PROJECT NO. 6018380**

TROPICAL SHORES

WHEREAS, a road and sewer project was approved for construction under the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582 Laws of Florida, as amended (the "Special Act"), and Resolution R-94-252, which confirmed the adoption of a special road and sewer assessment roll and established special assessment liens on real property designated as Tropical Shores Project No. 6018360 and 6018380; and

WHEREAS, said liens were recorded in Official Record Book 1699, Pages 7893-7937 certified August 28, 2001 by Resolution R-01-94, Official Record Book 1699, Pages 7893-7896; and

WHEREAS, the preliminary assessment rolls with reference to the above described project were properly filed with the Board of County Commissioners of Manatee County, Florida and said Board of County Commissioners did, pursuant to duly published notice, hold a public hearing on September 27, 1994 to consider the appropriateness of said road and sewer project and to consider objections to the confirmation of said preliminary rolls.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, after giving careful consideration to all evidence presented concerning objections to the confirmation of the preliminary assessment rolls, that said rolls be and the same is hereby confirmed in all respects, with the following exceptions (each of which represent reductions in assessment amounts) presented as amendments to the certified rolls.
