RESOLUTION NO. R-03-173

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS AUTHORIZING AND PROVIDING THE TERMS FOR A LICENSE TO USE REAL PROPERTY TO THE FLORIDA CENTRAL CREDIT UNION.

WHEREAS, §125.38, Florida Statutes, provides that a county may lease or convey real and personal property owned by the county to the United States or to any department or agency thereof, the State or any political subdivision or agency thereof, or any municipality of the State, or corporation or other organization not-for-profit which may be organized for the purpose of promoting community interest and welfare at such price, whether nominal or otherwise, as the board may fix; and

WHEREAS, Florida Central Credit Union, a not-for-profit organization promoting the community interest and welfare, in response to a request from representatives of the County, has applied to the County to install an automatic teller machine within facilities owned by the County in the downtown Bradenton area; and

WHEREAS, the Florida Central Credit Union, Inc., has historically provided credit union services to the Board of County Commissioners of Manatee County and its employees, and to Manatee County constitutional officers and their employees; and

WHEREAS, the Board is satisfied that a convenient location acceptable to Florida Central Credit Union and the County Administrator can be identified for locating an automatic teller machine that will serve the interests of employees and users of County facilities and that such space is not presently required for other purposes.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, THAT:

- 1. The Florida Central Credit Union is hereby granted a license to locate an automatic teller machine in County-owned buildings in the downtown Bradenton area at such location as is acceptable to the County Administrator.
- 2. The automatic teller machine shall be located in a County building solely at the risk of Florida Central Credit Union and any loss, whether to Florida Central Credit Union or the users of the machine, shall be borne by Florida Central Credit Union.
- 3. This license may be terminated at any time with ninety (90) days written notice to Florida Central Credit Union.
- 4. There shall be no consideration payable to Manatee County pursuant to this license agreement other than the benefit to the County, County employees, and users of County buildings.
