**A RESOLUTION MODIFYING THE SPECIAL ASSESSMENT ROLL FOR A
STREET LIGHTING PROJECT
RUBONIA**

WHEREAS, a street lighting project was approved for installation, operation and maintenance under the provisions of Chapter 125.01(G), Chapter 125.01(Q), Chapter 125.01(R) and Chapter 197.3632, Florida Statutes, and **Ordinance 91-66**, which confirmed the adoption of a special street lighting assessment roll and established special assessment liens on real property designated as **Rubonia**; and

WHEREAS, on **August 27, 1996**, the Board of County Commissioners adopted **Resolution R-96-195**, which amended the special street lighting assessment roll for Rubonia; and

WHEREAS, said liens were recorded in Official Record Book **1496**, Pages **5528-5681**, certified **August 27, 1996** by Resolution **R-96-195**, Official Record Book **1496**, Pages **5525-5527**; and

WHEREAS, on **September 7, 1999**, the Board of County Commissioners adopted **Resolution R-99-153**, which again amended the special street lighting assessment roll for Rubonia; and

WHEREAS, said liens were recorded in Official Record Book **1609**, Pages **3491-3530**, certified **September 7, 1999** by Resolution **R-99-153**, Official Record Book **1609**, Pages **3488-3490**; and

WHEREAS, on **August 14, 2001**, the Board of County Commissioners adopted **Resolution R-01-142**, which again amended the special street lighting assessment Roll for Rubonia; and

WHEREAS, said liens were recorded in Official Record Book **1697**, Pages **951-1006**, certified **August 14, 2001** by Resolution **R-01-142**, Official Record Book **1697**, Pages **948-950**; and

WHEREAS, the Ordinance with reference to the above described project was properly filed with the Office of the Secretary of State in Tallahassee, Florida and the Board of County Commissioners of Manatee County, Florida and said Board of County Commissioners did, pursuant to duly published notice, hold a public hearing on **August 13, 1991** to consider the appropriateness of said street lighting project and to consider objections to the confirmation of said roll.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, after giving careful consideration to all evidence presented concerning objections to the confirmation of the assessment roll, that said roll be and the same is hereby confirmed in all respects, with the following exceptions presented as amendments to the certified roll.
