

**A RESOLUTION MODIFYING THE SPECIAL ASSESSMENT ROLL FOR
STREET LIGHTING PROJECT
HOLIDAY HEIGHTS**

WHEREAS, a street lighting project was approved for installation, operation and maintenance under the provisions of Chapter 125.01(G), Chapter 125.01(Q), Chapter 125.01(R) and Chapter 197.3632, Florida Statutes, and **Ordinance 95-39**, which confirmed the adoption of a special street lighting assessment roll and established special assessment liens on real property designated as **Holiday Heights**; and

WHEREAS, the Ordinance with reference to the above described project was properly filed with the Office of the Secretary of State in Tallahassee, Florida and the Board of County Commissioners of Manatee County, Florida and said Board of County Commissioners did, pursuant to duly published notice, hold a public hearing on **September 12, 1995** to consider the appropriateness of said street lighting project and to consider objections to the confirmation of said roll.

WHEREAS, on **June 17, 2003**, the Board of County Commissioners adopted **Resolution R-03-101**, which amended the special street lighting assessment roll for Holiday Heights; and

WHEREAS, said liens were recorded in Official Record Book **1837**, Pages **5335-5348**, certified **June 17, 2003** by Resolution **R-03-101**, Official Record Book **1837**, Page **5334**; and

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, after giving careful consideration to all evidence presented concerning objections to the confirmation of the assessment roll, that said roll be and the same is hereby confirmed in all respects, with the following exceptions presented as amendments to the certified roll.




