

RESOLUTION R-04-118

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AMENDING RESOLUTION R-02-330 AND R-03-206 TO PROVIDE FOR REVISIONS TO THE 2002 AND 2003 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) AND HOME INVESTMENT PARTNERSHIP (HOME) PROGRAMS ANNUAL ACTION PLANS.

WHEREAS, on December 10, 2002, the Board of County Commissioners approved Resolution R-02-330 providing for the adoption of the Community Development 2002-2006 Consolidated Plan and the 2002 One Year Action Plan; and

WHEREAS, on August 5, 2003, the Board of County Commissioners approved Resolution R-03-206 providing for the adoption of the Community Development 2003 One Year Action Plan; and

WHEREAS, Resolutions R-02-330 and R-03-206 specifically approved several CDBG and HOME activities including the following six projects: 2002 and 2003 CDBG Family Resources Shelter Renovation, two (2) 2002 CDBG Manatee Children's Services Group Home Renovations, 2002 HOME Manasota Homeless Project Rental Assistance, 2002 HOME Community Coalition on Homelessness Rental Assistance, and 2002 HOME Manatee Opportunity Council Rental Assistance; and

WHEREAS, the six projects identified above require a substantial amendment to the original allocation of funds budgeted for each of the projects, as described in Attachment 1 and 2; and

WHEREAS, the process for amending a Consolidated Plan and/or Annual Action Plan is outlined in Manatee County's Citizen Participation Plan and each of those steps have been followed in this process, including the 30-day public comment period.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that:

1. Resolution R-02-330 is hereby amended to provide for adoption of Resolution R-04-118 to the Community Development 2002-2006 Consolidated Plan and the 2002 One Year Action Plan as attached hereto as Attachment 1.
2. Resolution R-03-206 is hereby amended to provide for adoption of Resolution R-04-118 to the 2003 One Year Action Plan as attached hereto as Attachment 2.
