

RESOLUTION R-04-155

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AMENDING RESOLUTION R-02-243 TO PROVIDE FOR REVISIONS TO THE LOCAL HOUSING ASSISTANCE PLAN (2000-2003).

WHEREAS, on May 2, 2000, the Board of County Commissioners approved Resolution R-00-89 providing for adoption of a Local Housing Assistance Plan (2000-2003), and

WHEREAS, on May 3, 2000, staff transmitted the revised plan to the Florida Housing Finance Corporation for review and approval.

WHEREAS, on June 5, 2000, Florida Housing Finance Corporation Review Committee approved the plan subject to the County completing minor technical revisions to the plan and resubmitting a complete copy of the plan with the revisions made in underline and strike-through format by August 3, 2000.

WHEREAS, on June 28, 2000, Florida Housing Finance Corporation Review Committee approved the revised plan which incorporates the minor technical revisions requested by the Florida Housing Finance Corporation Review Committee.

WHEREAS, through implementation of the Local Housing Assistance Plan (2000-2003) several revisions to the plan were warranted.

WHEREAS, on September 3, 2002, the Board of County Commissioners approved Resolution R-02-243 providing for adoption of certain revisions to the Local Housing Assistance Plan (2000-2003).

WHEREAS, due to the rising cost of housing, an amendment to the maximum allowable sales price for existing and new construction is needed.

WHEREAS, due to the increase in the maximum allowable sales price for existing and new construction, an amendment to the Maximum SHIP Award per unit for Homeownership Strategies is now warranted.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that:

1. Resolution R-02-243 is hereby amended to provide for adoption of Resolution R-04-155 to the Local Housing Assistance Plan (2000-2003) as attached hereto as Attachment 1.
2. The Board of County Commissioners of Manatee County shall reserve the right to adopt additional rules, policies and procedures that are consistent with the provisions of Section 420.907 et seq, Florida Statutes and the provisions of Chapter 67-37, Florida Administrative Code as well as any other applicable laws, codes or rules.
