## RESOLUTION APPROVING CERTAIN CO-PAYMENTS/ADJUSTMENTS/DENIED MEDICAID BILLING EFFECTIVE ON OR AFTER OCTOBER 1, 2003.

WHEREAS, the County of Manatee, a political subdivision of the State of Florida, is engaged in the operation of furnishing transportation service for persons located in Manatee County, Florida, and the governmental division of the County of Manatee, Florida, operating said transportation services is identified as the Manatee County Area Transit (MCAT), and

WHEREAS, MCAT electronically bills Medicaid for their client's monthly bus pass through the Agency for Health Care Administration, Florida Medicaid Program (AHCA), and

WHEREAS, the Manatee County Clerk of the Circuit Court has requested that the Manatee County Board of County Commissioners, in accordance with generally accepted accounting principles, designate co-payments/adjustments/denied charges incurred by AHCA, as uncollectible for the purpose of writing off these account receivables against the Allowance for Doubtful Account in the General Fund which has been established by the Finance Department of the Clerk of the Circuit Court.

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, THAT:

Section 1: Uncollectible co-payment/adjustment/denied billings that have been incurred by AHCA, effective on or after October 1, 2003, are hereby designed as uncollectible for the purpose of writing off these account receivables against the Allowance for Doubtful Accounts in the General Fund which has been established by the Finance Department of the Clerk of the Circuit Court. The reason for this designation is the inability of Manatee County to collect these co-payments/adjustments/denied charges from AHCA in the amount of \$805.00 (Exhibit A).

Section 2: The above designations have been made solely to enable the Clerk of the Circuit Court to carry out his duties in accordance with generally accepted accounting principles.
