**A RESOLUTION MODIFYING THE SPECIAL ASSESSMENT ROLL FOR A  
STREET LIGHTING PROJECT  
SUNNY SHORES**

**WHEREAS**, a street lighting project was approved for installation, operation and maintenance under the provisions of Chapter 125.01(G), Chapter 125.01(Q), Chapter 125.01(R) and Chapter 197.3632, Florida Statutes, and **Ordinance 01-39**, which confirmed the adoption of a special street lighting assessment roll and established special assessment liens on real property designated as **Sunny Shores**; and

**WHEREAS**, the Ordinance with reference to the above described project was properly filed with the Office of the Secretary of State in Tallahassee, Florida and the Board of County Commissioners of Manatee County, Florida and said Board of County Commissioners did, pursuant to duly published notice, hold a public hearing on **August 21, 2001** to consider the appropriateness of said street lighting project and to consider objections to the confirmation of said roll.
