

RESOLUTION NO. R-04-257

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, ESTABLISHING REVISED CONTRACTOR EXAMINATION, LICENSING, AND OTHER RELATED FEES AND CHARGES; ADOPTING AND ESTABLISHING SCHEDULE OF CONTRACTOR EXAMINATION, LICENSING, AND OTHER RELATED FEES AND CHARGES; PROVIDING FOR AMENDMENT OF SCHEDULE OF FEES AND CHARGES; REPEALING AND SUPERSEDING CONFLICTING RESOLUTIONS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 489.117, Florida Statutes, authorizes counties, municipalities, and development districts to issue local licenses for contractors corresponding to the categories defined in Subsection 489.105(3), Florida Statutes, and for local specialty contractors; and

WHEREAS, Chapter 2-6, Article V, Code of Ordinances of Manatee County, Florida, provides rules and regulations for contractors in unincorporated Manatee County; and

WHEREAS, Section 2-6-73, Code of Ordinances of Manatee County, Florida, establishes requirements for contractors in unincorporated Manatee County, including payment of any applicable fees; and

WHEREAS, Subsection 2-6-76(a), Code of Ordinances of Manatee County, Florida, provides that fees for examination and licensing of contractors shall be established by resolution of the Board of County Commissioners; and

WHEREAS, the Manatee County Building Department has reviewed and recommended approval of the schedule of contractor examination, licensing, and other related fees and charges proposed in this resolution; and

WHEREAS, the Board of County Commissioners of Manatee County has

determined that the schedule of contractor examination, licensing, and other related fees and charges established in this resolution is reasonably related to the costs incurred by the County in providing such services.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:

Section 1. The Board of County Commissioners hereby establishes revised contractor examination, licensing, and other related fees and charges as set forth in Attachment "A", entitled "Building Department Fee Schedule", which is attached hereto and incorporated herein by reference. Attachment "A" is hereby adopted and established as the schedule of contractor examination, licensing, and other related fees and charges for unincorporated Manatee County.

Section 2. The schedule of fees and charges set forth in Attachment "A" may be amended in whole or in part by any subsequent resolution adopted by the Board of County Commissioners.

Section 3. Effective January 1, 2005, at 12:01 a.m., all resolutions and parts of resolutions in conflict with the provisions of this resolution, including, but not limited to, Resolution No. R-03-223, shall be repealed, rescinded, superseded and replaced by this resolution to the extent of such conflict.

Section 4. In the event that any provision, portion or section of this resolution is determined to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such decision shall in no manner affect the remaining provisions, portions or sections of this resolution which shall remain in full force and effect.

Section 5. This resolution and the fees and charges established in this resolution shall take effect January 1, 2005, at 12:01 a.m.

Renewal

- The renewal fee is the same as the original license fee. Certificates of Competency shall expire on September 30th annually, and valid Certificates may be renewed through September 30th of each year. Licenses renewed after the September 30th expiration date shall be subject to the following penalty fee, in addition to the license fee:

Inactive Fee	\$	36.00	<u>38.00</u>	- each.

<u>October 1st to November 30th</u>	- 25% of total fee.
<u>1 to 30 days after September 30th</u>	- 50% of renewal or inactive fee
<u>31 days to 1 year after September 30th</u>	- 100% of renewal or inactive fee

Note: All persons who fail to renew a Certificate of Competency ~~one year after its date of expiration~~ by December 1st must apply for a new Certificate of Competency, meeting current licensing requirements, and must take and pass the appropriate ~~Block and Associates~~ Experior examination prior to the issuance of another certificate. ~~Penalty fee not applicable to journeyman plumbers.~~
