**A RESOLUTION MODIFYING THE SPECIAL ASSESSMENT ROLL FOR
ROAD ASSESSMENT PROJECT NO. 5075**

21ST STREET WEST

WHEREAS, a road project was approved for construction under the provisions of Chapter 153, Florida Statutes, and Chapter 63-1582, Laws of Florida, as amended (the "Special Act"), and Resolution **R-88-219**, which confirmed the adoption of a special road assessment roll and established special assessment liens on real property designated as **21st Street West** Project No. **5075**; and

WHEREAS, said liens were recorded in Official Record Book **1250**, Pages **0404-0421**, certified **February 14, 1989** by Resolution **R-90-45**, Official Record Book **1250**, Pages **0405-0406**; and

WHEREAS, the preliminary assessment roll with reference to the above described project was properly filed with the Board of County Commissioners of Manatee County, Florida and said Board of County Commissioners did, pursuant to duly published notice, hold a public hearing on **October 4, 1988** to consider the appropriateness of said sewer project and to consider objections to the confirmation of said preliminary roll.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, after giving careful consideration to all evidence presented concerning objections to the confirmation of the preliminary assessment roll, that said roll be and the same is hereby confirmed in all respects, with the following exceptions (each of which represent reductions in assessment amounts) presented as amendments to the certified roll.
