

RESOLUTION R-04-286

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AMENDING RESOLUTION R-02-330 TO PROVIDE FOR REVISIONS TO THE 2002 ONE YEAR ACTION PLAN.

WHEREAS, on December 10, 2002, the Board of County Commissioners approved Resolution R-02-330 providing for the adoption of the Community Development 2002-2006 Consolidated Plan and the 2002 One Year Action Plan; and

WHEREAS, Resolution R-02-330 specifically approved several CDBG activities including the following four projects: Latin Chamber of Commerce, Meals on Wheels PLUS/Senior Center, CDBG General Administration, Repetitive Crime Initiative; and

WHEREAS, the four projects identified above require a substantial amendment to the original allocation of funds budgeted for each of the projects, as described in Attachment 1; and

WHEREAS, the process for amending a Consolidated Plan and/or Annual Action Plan is outlined in Manatee County's Citizen Participation Plan and each of those steps have been followed in this process, including the 30-day public comment period.

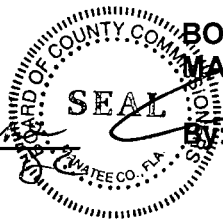

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that:
