

RESOLUTION R-04-299

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AMENDING RESOLUTION R-04-156 TO PROVIDE FOR REVISIONS TO THE LOCAL HOUSING ASSISTANCE PLAN (2003-2006).

WHEREAS, on April 22, 2003, the Board of County Commissioners approved Resolution R-03-80 providing for adoption of a Local Housing Assistance Plan (2003-2006); and

WHEREAS, on April 29, 2003, staff transmitted the plan to the Florida Housing Finance Corporation for review and approval; and

WHEREAS, on May 13, 2003, Florida Housing Finance Corporation Review Committee approved the plan subject to the County completing minor technical revisions to the plan and resubmitting a complete copy of the plan with the revisions made in underline and strike-through format by June 27, 2003; and

WHEREAS, on June 26, 2003, Florida Housing Finance Corporation Review Committee approved the revised plan which incorporates the minor technical revisions requested by the Florida Housing Finance Corporation Review Committee; and

WHEREAS, on March 9, 2004, the Board of County Commissioners approved Resolution R-04-87, providing for adoption of certain revisions to the Local Housing Assistance Plan (2003-2006); and

WHEREAS, on June 8, 2004, the Board of County Commissioners approved Resolution R-04-156, providing for adoption of certain revisions to the Local Housing Assistance Plan (2003-2006); and

WHEREAS, due to the impact of several natural disasters, the establishment of a Disaster Relief Assistance Strategy is required in order to provide SHIP funding assistance to eligible households who are victims of natural disaster; and


WHEREAS, due to the rising cost of housing, an amendment to the maximum allowable sales price for existing and new construction is needed; and

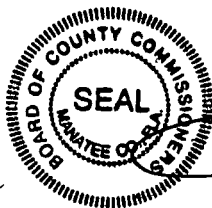
NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that:

1. Resolution R-04-156 is hereby amended to provide for adoption of Resolution R-04-299 to the Local Housing Assistance Plan (2003-2006) as attached hereto as Attachment 1.

The Board of County Commissioners of Manatee County shall reserve the right to adopt additional rules, policies and procedures that are consistent with the provisions of Section 420.907 et seq, Florida Statutes and the provisions of Chapter 67-37, Florida Administrative Code as well as any other applicable laws, codes or rules.
