RESOLUTION NO. R-11-020

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AMENDING EXHIBIT A AND C WITH RESPECT TO THE OPERATION AND USE OF MANATEE COUNTY PARKS AND RECREATION FACILITIES AND PROGRAMS; ESTABLISHING A FEE SCHEDULE; PREVIOUSLY ADOPTED BY RESOLUTION 10-121; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, §125.01(1)(f), Florida Statutes, authorizes the Board of County Commissioners of Manatee County, Florida, as the legislative and governing body of Manatee County, to provide parks, preserves, playgrounds, recreation areas, and other recreation and cultural facilities and programs; and

WHEREAS, Manatee County has previously adopted resolutions establishing policies and fees for the use of Manatee County parks and recreation facilities; and

WHEREAS, parks and recreation facilities are used for planned recreational programs, special events, field trips, and numerous activities reflecting the interests and desires of the residents of Manatee County; and

WHEREAS, parks and recreation programs are funded in part by fees generated to cover all or a portion of the costs of such programs; and


WHEREAS, parks and recreation programs provide valued support and assistance in implementing recreational programs for the community and developing facilities in Manatee County's parks.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AS FOLLOWS:

1. The manual of policies, fee schedules, and implementing documents attached hereto and incorporated herein is hereby adopted.
2. Except as otherwise provided herein, this Resolution shall take effect February 23, 2011.

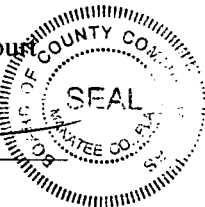

- N. **“Group”** – Any legally established organization or entity.
- O. **“Season”** – A season is three to four months of play which includes tryouts, practice, games and one league tournament.
- P. **“Corporate”** – A non-profit or for-profit corporation with 50 employees or more that registers with the Parks and Recreation Department. The employee must show proof of employment with that corporation with a recent pay stub (issued within the last two weeks of employment) or authorized current identification card. This also includes County employees.
- Q. **“Bank Draft Payment”** – An automatic monthly payment from the member’s bank account so that member’s can pay their annual membership fee on a monthly basis. At time of enrollment members must pay for the first and last month which is non refundable. The last month’s payment is automatically applied to the 12th month of the membership and is forfeited should the member decide to terminate their membership early. Payment is continuous until the membership is terminated by the member. Termination is effective 30 days after the notice is received by the member. Bank fees for this convenience may be passed to the customer.
- R. **“Seasonal Membership** – Gives Seniors the opportunity to place their annual membership on hold. Individuals must give 30 days notice to put their annual membership on hold and pay a transaction fee of \$25.00. This membership expires after two (2) years from date of activation.
- S. **“Fitness Center Membership (Grandfather Clause)”** – this pertains to all existing monthly members of the fitness center as of June 1, 2010 as well as seasonal residents who held a membership during the time period of October 1, 2009 to March 31, 2010. This is a onetime offer that allows them to utilize only the fitness center at the rate of \$25.00/month until they have a lapse in their membership. In addition, seasonal members have the opportunity to place their fitness membership on hold and pay a transaction fee of \$25.00. This membership expires after two (2) years from the date of activation.
- T. **“Racquetball & Hard Court Tennis Membership (Grandfather Clause)”** – this pertains to all existing members of Racquetball and Hard Court Tennis who have joined as of June 1, 2010 at the rate of \$60.00 for three (3) months or at the rate of \$95.00 for six (6) months to allow them to utilize only Racquetball & Hard Court Tennis until they terminate their membership.
- U. **“Non-Profit Organization Membership”** – non-profit organizations, including but not limited to Family Resources and Manatee Glens, will be authorized to purchase transferable annual recreation memberships for individuals in their care and for staff who chaperone them. This partnership will enable these individuals to participate in recreational activities that they otherwise wouldn’t have access to. As individuals rotate in and out of these facilities, the annual membership may be transferred from one person to another, however, at no time may the number of participants exceed the number of passes purchased without paying the appropriate fees.
- V. **“Coupons”** – coupons for discount rates and membership incentives ^{may} will be offered throughout the year to promote programs and memberships. Coupons will be offered in the range of 10% to 20% discounts to be applied towards program, activity, and/or membership fees.
