

**RESOLUTION R-11-059**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AMENDING THE 2010/11 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ANNUAL ACTION PLAN**

**WHEREAS**, on June 8, 2010, the Board approved Resolution R-10-077 adopting the Community Development Block Grant 2010/11 Annual Action Plan; and

**WHEREAS**, Resolution R-10-077 specifically approved CDBG and HOME activities; and

**WHEREAS**, this substantial amendment reallocates a portion of HOME funding from the 2010/11 Action Plan; and

**WHEREAS**, the process for amending a Consolidated Plan and/or Annual Action Plan is outlined in Manatee County's Citizen Participation Plan and each of those steps have been followed in this process, to include a 30-day public comment period.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners that:

1. Resolution R-11-059 is hereby adopted to provide for an amendment to the 2010/11 Annual Action Plan as attached hereto.
2. The County Administrator, or designee, is hereby authorized to approve and execute HOME funding agreements and authorize payments up to the maximum allowable funding for Federal HOME program activities as approved and adopted by the Board of County Commissioners in Manatee County's Consolidated Plan and Annual Action Plans and amendments.
