

RESOLUTION NO. R-11-79

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, ESTABLISHING REVISED BUILDING AND DEVELOPMENT SERVICES DEPARTMENT MISCELLANEOUS FEES AND CHARGES; PROVIDING DIRECTIONS REGARDING CODIFICATION; REPEALING AND SUPERSEDING CONFLICTING RESOLUTIONS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 125.01, Florida Statutes, authorizes the board of county commissioners to exercise the power to carry on county government, provided that such power is not inconsistent with general or special law; and

WHEREAS, Manatee County incurs costs for miscellaneous services provided by Building and Development Services Department staff, including issuing permits for driveways, commercial non-structural fences, and temporary uses, notarizing documents, researching building and land use issues, and reviewing plans for compliance with zoning requirements; and

WHEREAS, the Board of County Commissioners desires to have such costs paid for by persons utilizing the services; and

WHEREAS, the Manatee County Building and Development Services Department has reviewed and recommended approval of the revised miscellaneous fees and charges proposed in this resolution; and

WHEREAS, the Board of County Commissioners of Manatee County has determined that the miscellaneous fees and charges established in this resolution are reasonably related to the costs incurred by the County in providing such services.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:

Section 1. Building and Development Services Department miscellaneous fees and charges. The Board of County Commissioners hereby establishes the following revised miscellaneous fees and charges for the Building and Development Services Department:

TYPE OF SERVICE	FEE OR CHARGE
Driveway Permit	\$142.00 per permit
Fence Permit - Commercial Non-Structural	\$175.00 per permit
Notary Acknowledgement	\$5.00 per document
Research (one hour minimum)	\$40.00 per hour
Temporary Use Permit	\$435.00 per permit
Temporary Use Permit with Tent	\$450.00 per permit
Zoning Review - Agricultural, Exemption, Residential Non-Structural Fence	\$104.00 per review

Section 2. Directions regarding codification. This resolution shall not be codified in the Manatee County Code of Resolutions.

Section 3. Conflicting resolutions. Effective May 1, 2011, all resolutions and parts of resolutions in conflict with the provisions of this resolution, including, but not limited to, Resolution No. R-08-83, shall be repealed, rescinded, superseded, and replaced by this resolution to the extent of such conflict.

Section 4. Severability. In the event that any provision, portion or section of this resolution is determined to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such decision shall in no manner affect the remaining provisions, portions or sections of this resolution which shall remain in full force and effect.

Section 5. Effective date. This resolution and the fees and charges established in this resolution shall take effect May 1, 2011.

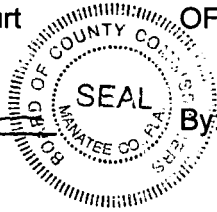
