

**RESOLUTION NO. R-11-116**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, REVISING THE PARK & RECREATION FEE SCHEDULE; MAKING RELATED FINDINGS; RESCINDING RESOLUTION 10-168; PROVIDING FOR CONFLICTING PRIOR RESOLUTIONS; PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, §125.01(1)(f), Florida Statutes, authorizes the Board of County Commissioners of Manatee County, Florida, as the legislative and governing body of Manatee County, to provide parks, preserves, playgrounds, recreation areas, and other recreation and cultural facilities and programs; and

**WHEREAS**, parks and recreation services are funded in part by user fees generated to cover all or a portion of the costs of such services so as to minimize the burden on the County's general revenue; and

**WHEREAS**, Manatee County Code § 2-24-12 provides that the Board of County Commissioners may, upon recommendation of the parks director, adopt, modify or rescind fees or fee ranges for access to various facilities or services offered by the County; and

**WHEREAS**, the County Commission has previously adopted various fees which have been made a part of the Parks & Recreation Master Fee Schedule; and

**WHEREAS**, the new or revised fees now recommended for adoption are based upon the addition of new programming or services, and/or changes to programming, services, and/or facilities costs, as well as anticipated revenue from other sources.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AS FOLLOWS:**

**BE IT FURTHER RESOLVED** that the provisions of this Resolution are severable such that the invalidity of any one provision shall not operate to invalidate any other provision.
