

RESOLUTION NO. R-11-131

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, RELATING TO THE BOARD OF COMMISSIONERS OF THE MYAKKA CITY FIRE CONTROL DISTRICT; APPOINTING COMMISSIONERS TO DISTRICT SEAT 1, DISTRICT SEAT 3, AND DISTRICT SEAT 5; PROVIDING DIRECTIONS REGARDING CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on May 8, 2007, the Board of County Commissioners of Manatee County, Florida, adopted and enacted Ordinance No. 07-56, codified as Chapter 2-27 of the Manatee County Code of Ordinances, providing for the Myakka City Fire Control District; and

WHEREAS, Section 2-27-3 of the Manatee County Code of Ordinances provides that the business and affairs of the Myakka City Fire Control District shall be conducted and administered by a board of five (5) commissioners; and

WHEREAS, Section 2-27-4 of the Manatee County Code of Ordinances provides that the Board of County Commissioners shall by resolution appoint the five (5) commissioners of the district board to staggered terms of four (4) years each; and

WHEREAS, on June 19, 2007, the Board of County Commissioners appointed the five (5) commissioners of the district board of the Myakka City Fire Control District; and

WHEREAS, pursuant to Section 2-27-4 of the Manatee County Code of Ordinances, each commissioner of the district board appointed to an odd-numbered seat was appointed for an initial term of four (4) years commencing on June 1, 2007; and

WHEREAS, since the initial terms of office of the commissioners appointed to the odd-numbered seats will expire on May 31, 2011, the Board of County Commissioners desires to appoint commissioners to District Seat 1, District Seat 3, and District Seat 5 of the Myakka City Fire Control District for a term of four (4) years each.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:

Section 1. The Board of County Commissioners hereby appoints the following commissioners of the Myakka City Fire Control District for a term of four (4) years each commencing on June 1, 2011:

- a. Mark W. Bandstra to District Seat 1;
- b. Charles J. Matson to District Seat 3; and
- c. James E. Parker to District Seat 5.

Section 2. This resolution shall not be codified in the Manatee County Code of Resolutions.

Section 3. This resolution shall take effect on June 1, 2011.
